Role Description

To ensure that all proactive and reactive investigations into complex, organised, acquisitive and serious crimes are fully and expeditiously investigated through the supervision and development of Investigation team members in order to detect the crime(s) and allow a considered decision to be taken about the prosecution of offenders.

Main Responsibilities

- Assess risk, prioritise and allocate all detainees, tasking, referrals and crime incidents to the appropriate team and investigators with the necessary skills and resilience to effectively manage and conduct the necessary investigation to optimise prosecutions.
- Develop and set quality investigative strategies, providing advice regarding points of law, force policies and procedures and building in regular reviews.
- Manage proactive intelligence development of organised crime groups and submission of quality information.
- Promote the 'one team' ethos, ensuring interoperability across the Investigations Directorate.
- Provide advice and strategy around specialist capability to respond and manage 'crime in action' investigations.
- Identify covert tactics opportunities to secure evidence to bring offenders to justice.
- Develop and enhance engagement with other internal departments and external agencies to improve service to the public.
- Identify and organise the necessary training and development for staff to maintain high professional standards and investigative skills.
- Manage investigators' welfare, performance and any absence issues.
- Drive safeguarding and promote the welfare of all children and vulnerable adults in all policing across the force
- Consider unexplained and sudden deaths responsibility
